## **Proposal to Update the Faculty Senate Bylaws**

# Article I Section 2. Membership, Article IV Sections 1.1 & 1.2. Regular Meetings, & Genderneutral language

## Current Bylaws Language: Article 1, Section 2. Membership

Section 2. Faculty units, for purposes of representation, include the following:

1) Behavioral Science; 2) Business & Economics; 3) Computer Science; 4) Creative
Arts; 5) Deaf Studies and Professional Studies; 6) Education and Leadership; 7) Health
and Exercise Science; 8) Humanities; 9) Library & Media Services; 10) Natural Sciences
and Mathematics; and 11) Social Science.

#### Proposed Updated Language:

Section 2. Faculty units, for purposes of representation, include the following:

1) Behavioral Sciences; 2) Business & Economics; 3) Computer Science; 4) Creative Arts; 5) Criminal Justice; 6) Deaf Studies and Professional Studies; 7) Education and Leadership; 8) Health and Exercise Science; 9) Humanities; 10) Library & Media Services; 11) Natural Sciences and Mathematics; and 12) Social Science.

#### **Current Bylaws Language: Article IV, Sections 1.1, 1.2. Regular Meetings**

- 1.1 Regular meetings of the Faculty Senate are held during each of the following months: October, November, December, January, February, March, April, May, and July.
- 1.2 Regular meetings of the Faculty Senate are held from 3:30 to 5:00 p.m. on the second and fourth Tuesday of each month, except only one meeting will be held in December, March, and July on the second Tuesday.

## <u>Proposed Updated Language:</u>

- 1.1 Regular meetings of the Faculty Senate are held during each of the following months: October, November, December, January, February, March, April, May, and June. If deemed necessary at the June meeting, a special meeting for the second Tuesday in July at the regular meeting time may be scheduled by a motion stating the purpose of the meeting. This motion requires a majority to pass.
- 1.2 Regular meetings of the Faculty Senate are held from 3:30 to 5:00 p.m. on the second and fourth Tuesday of each month, except only one meeting will be held in December, March, and June on the second Tuesday.

# **Current Bylaws Language:**

**Article III, Section 3.3.3** Carry out any duties of the president of the Faculty Senate dealing with Faculty Senate affairs while serving in his/her stead.

**Article IV, Section 5.1** When a faculty senator is on leave or sabbatical, his/her faculty unit may designate an alternate for the period of vacancy.

# **Proposed Updated Language:**

**Article III, Section 3.3.3** Carry out any duties of the president of the Faculty Senate dealing with Faculty Senate affairs while serving in their stead.

**Article IV, Section 5.1** When a faculty senator is on leave or sabbatical, their faculty unit may designate an alternate for the period of vacancy.
