 - i. Requested budget less than FY20
 - ii. Cut would affect food pantry staff member compensation
- iii. Now one area budget
- iv. Budget cut of 2.5% By the ears of the Chair the Ayes have it cut approved

 - i. Rip: Q: Is the van paid out of IFC fees. Camarie: A: IFC fees, one-time money. They put money in their equipment reserve for repairs and replacement of vehicle.

 - a. \$99,775 Enhancement request
 - i. The money will go back directly back into their base budget

- c. \$1,000 Men's Club Basketball
 - i. Makana: Q: Do they fundraise? Rip: A: They fundraise it all.

 - v. If granted it will increase the budget for next year to keep paying for subscription.
