- 5. 2020-21 Timeline Discussion
 - Update from NJ
 - i. President Fuller and NJ worked on presentation to board.
 - ii. Per General Council: IFC would not need to go through board subcommittee to charge fee for winter term.
 - iii. Per Vice President & General Council Ryan Hagemann: Feasible to charge a fee. Go through board meeting. Adjusting the fee amount and clarify who pays.
 - iv. November 18, 2020 board meeting, request fee a week in advance of meeting November 11.
 - Fee request for winter term would need to be decided within the next 2 IFC meetings.
 - vi. Question: University stimulus discussion?
 - vii. NJ: Yes, there was but nothing was decided, stimulus for winter term \$1M possible, revenue from online tech fee.
 - viii. Juliana: when will we have an actual idea?
 - ix. NJ: I cannot say anything for certain right now.
 - x. Juliana and NJ meet with President Fuller to get a solid answer.



Fall 2020 week-to-week timeline

- i. Hard deadline, request in by November 11, 2020.
- ii. Rip: In IFC objective: IFC members have cameras on.
- iii. Liz: Has IFC been provided with enrollment numbers and revenue projection?
- iv. Dave M.: Student enrollment is typically based on 4th week census. We are not there yet sometime in 5th week we will have headcount/ FTE. Winter enrollment is more important. Winter registration has not started yet. Use fall and normal trends.
- v. Quentin: We can expect a much larger drop.
- vi. Darin: \$140,000 normal IFC process, \$143,000 now. I guess not a whole lot different for winter.
- vii. Liz: Understand we need to verify numbers, could you provide numbers information to committee?
- viii. Dave: once available happy to provide.

6. Winter 2021 Fee discussion:

- What are we thinking for fee?
 - i. Nick: Data point what we are aiming for is what we can discuss. It is hard to say what we should charge student to get to \$1M. We don't know how many students we are charging. Lots of info we still need.
 - ii. NJ: Whatever fee you decide on will be filled in from stimulus to make our total.
 - iii. Quentin: We should charge a fee, not just to keep service and staff, to give students a say. We should charge as little as possible.
 - iv. Juliana: Agree with minimum fee. Pull some form reserve. \$25.00 fee to keep it affordable.



- v. Nick: Makes sense. Thanks Quentin. Keep thing minimal for students.
- vi. Rip: Please clarify: do we know what the total is that area heads are requesting?
- vii. Juliana: Not put together yet. Can do that after presentations.
- viii. Winter is overall less expensive for IFC budget.
- ix. Nick: Do we need to reach out to students prior to putting online student as fee paying student on the docket?
- x. Steven: It is in the Board of trustees' court. IFSC made the change and board of trustees needs to sign on to the change.
